Following is the final form of amendments proposed by the Bylaws Committee and the Board. The four proposed amendments will be voted on individually at the September 7 Club meeting.

### **Final Form of Amendments to DTCDC Bylaws Proposed at July 25, 2019 Meeting of Board and Bylaws Committee (proposed changes are highlighted in yellow)**

#### **#1 – Quorum requirement**

**Current:**

#### **ARTICLE V – MEETINGS AND VOTING**

#### **Section 1. Club Meetings**

Meeting(s) of the Club shall be held monthly at the DTCDC Club building at such time as may be designated by the Board. Notice of each such meeting shall be given not less than five (5) days prior to the date of the meeting. The quorum for meetings shall be 20 percent of Active Members.

**Final Form of Proposed Amendment:**

#### **ARTICLE V – MEETINGS AND VOTING**

#### **Section 1. Club Meetings**

Meeting(s) of the Club shall be held monthly at the DTCDC Club building at such time as may be designated by the Board. Notice of each such meeting shall be given not less than five (5) days prior to the date of the meeting. The quorum for meetings shall be **10** percent of Active Members.

#### **Discussion and/or Materials that Informed the Board/Bylaws Committee Amendment Proposal:**

##### Texas Statutes Governing Nonprofit Corporations

DTCDC is a Texas Nonprofit Corporation. The proposed 10% is the standard percentage recommended in the Texas Statutes governing Nonprofit Corporations. See below.

BUSINESS ORGANIZATIONS CODE, TITLE 2. CORPORATIONS, CHAPTER 22. NONPROFIT CORPORATIONS, SUBCHAPTER A. GENERAL PROVISIONS

Sec. 22.159. QUORUM OF MEMBERS. (a) Unless otherwise provided by the certificate of formation or bylaws of a corporation, members of the corporation holding one-tenth of the votes entitled to be cast, in person or by proxy, constitute a quorum.

##### Roberts Rules of Order

The Board and Bylaws Committee also took note of Roberts Rules, Art. XI. Miscellaneous. 64. Quorum: "A Quorum of an assembly is such a number as must be present in order that business can be legally transacted. The quorum refers to the number present, not to the number voting. The quorum of a mass meeting is the number present at the time, as they constitute the membership at that time."

## #2 – Nominating Committee Chair

**Current:**

### **ARTICLE VI – THE CLUB YEAR, ANNUAL MEETING AND ELECTIONS**

#### **Section 4. Nominations**

No person may be a candidate in a Club election who has not been nominated in advance by one of the following procedures:

A. At the August regular meeting of the Club, a Nominating Committee shall be elected by ballot. Each Active Member in good standing and in attendance will be allowed to submit five (5) names on the elective written ballot. The five (5) members receiving the highest number of votes shall serve as the Nominating Committee, with the person receiving the greatest number of votes as chair. Any tie shall be decided by a run-off ballot.

**Final Form of Proposed Amendment:**

#### **Section 4. Nominations**

No person may be a candidate in a Club election who has not been nominated in advance by one of the following procedures:

A. At the August regular meeting of the Club, a Nominating Committee shall be elected by ballot. Each Active Member in good standing and in attendance will be allowed to submit five (5) names on the elective written ballot. The five (5) members receiving the highest number of votes shall serve as the Nominating Committee, with the person receiving the greatest number of votes as chair. Any tie shall be decided by a run-off ballot. **A Corporate Director will be on the Committee as a non-voting advisor.**

**Discussion and/or Materials that Informed the Board/Bylaws Committee Amendment Proposal:**

Input from membership and the Corporate Directors stated they preferred to be non-voting advisors.

## #3 – Treasurer Disbursement Limits

**Current:**

### **ARTICLE III – DIRECTORS AND OFFICERS**

#### **Section 2. Officers**

E. The Treasurer shall collect and receive all moneys due or belonging to the Club. He or she shall deposit the same in a bank approved by the Board in the name of the Club. The Treasurer shall disburse moneys for the routine operating expenses of the Club and may disburse up to two hundred dollars (\$200.00) for miscellaneous Club expenses. Amounts over two hundred dollars (\$200.00) are to be approved by the members of the Club; except in cases of dire emergency, in which case a majority of the Board may authorize payment.

**Final Form of Proposed Amendment:**

E. The Treasurer shall collect and receive all moneys due or belonging to the Club. He or she shall deposit the same in a bank approved by the Board in the name of the Club. The Treasurer shall disburse moneys for the routine operating expenses of the Club and may disburse up to **five** hundred dollars (**\$500.00**) for miscellaneous Club expenses. Amounts over **five** hundred dollars (**\$500.00**) are to be approved by the members of the Club; except in cases of dire emergency, in which case a majority of the Board may authorize payment.

#### #4 – Include Email as Method for Notices to Members

Current:

#### ARTICLE V – MEETINGS AND VOTING

##### Section 1. Club Meetings

Meeting(s) of the Club shall be held monthly at the DTCCDC Club building at such time as may be designated by the Board. Notice of each such meeting shall be given not less than five (5) days prior to the date of the meeting. The quorum for meetings shall be 20 percent of Active Members.

##### Final Form of Proposed Amendment Proposed:

Meeting(s) of the Club shall be held monthly at the DTCCDC Club building at such time as may be designated by the Board. Notice of each such meeting shall be given not less than five (5) days prior to the date of the meeting. The quorum for meetings shall be **10** percent of Active Members. **Any notice to members required by these Bylaws may be provided by email unless expressly stated otherwise.**

I think the German Shepherd puppy and the Newfoundland puppy doubled in size every week! Of course, the two little Yorkies stayed tiny and precious, not to mention being the two most challenging at times. Got to love the terriers!

The puppies also absorb training like little sponges! It is amazing how fast they learn. It is hard for the humans to keep up!

We are always in need of Puppy instructors as we often add a Puppy class to accommodate the number of students registering for class. Since the window of opportunity for Puppy class is short, we are reluctant to ever turn away puppies.

If any of you are interested in becoming a Puppy instructor, you must first become a CGC Evaluator because our Puppy classes are S.T.A.R Puppy classes and must be taught by a CGC Evaluator. Even if you are not interested in evaluating the CGC tests or Trick Dog tricks, you could become an evaluator just to instruct Puppy class.

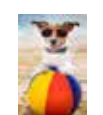
