Instructor/Assistant Corner:

Our new student handbook instructs the handler/student to NOT use a command/cue when first luring a new behavior.

As the student is trying to learn to successfully lure the dog, the dog is not sitting so the word "Sit", if being repeated, is not getting properly paired with the behavior (sit). The word is just background noise to the dog and the dog is learning "Sit" means nothing. He is learning to ignore it! This concept is called Learned Irrelevance in Behavioral Science.

So, instead, we wait until the student can successfully lure their dog into position at least 80% of the time. Now, when you add the cue, it is paired with the behavior(sit) each time and the dog learns the meaning of the word. For those of you who compete, you wait until you can lure the perfect position (such as a nice tight, tucked, up-sit) before you add the cue so the dog learns that "Sit" means assume that pretty competition-worthy position.

This concept of Learned Irrelevance and other training concepts are discussed in the new book we are adding to our library, EXCEL-erated LEARNING: Explaining How Dogs Learn and How Best to Teach Them by Pamela J. Reid, Ph.D.

The Three Musketeers and Me

They have been the driving forces in winning over my two young granddaughters who were afraid of dogs. Every day is a new adventure to look forward to and every evening nice

snuggle time on the couch. My house is truly now a home again with a little dog hair everywhere and I have to be careful not to step on Skye as she is the total shadow. To say I am so grateful to have them in my life is an understatement. Here is to new adventures and challenges for me and My Three Musketeers. As I said earlier, little did I know that photo of a few years ago was a peek into what the future would hold.






Chair leg rubber tips



The <u>Highest Average Obedience Score Award and Highest Average Rally Score Award</u> are awarded to the club member achieving the highest average score on the three legs required to earn an Obedience Title (i.e., CD, CDX, UD equivalent from AKC, ASCA, UKC) and the club member achieving the highest average score on the three legs required to earn a Rally Title (i.e., RN, RA, RE equivalent from AKC, ASCA, UKC). **To qualify: By November 15th Club members submit the form on the next page indicating the dates, names of the shows, and the scores for each leg to the Purchasing Committee Chairperson**, who determines which club members had the highest average Obedience and Rally scores. The third leg of the eligible scores must be earned during the period of November 15 of the previous year to November 14 of the current year. There is no limit on the number of times a club member may earn and receive these awards. The awards are presented annually by DTCDC.

The <u>Most Improved Obedience Score Award and Most Improved Rally Score Award</u> are awarded to the club member achieving the greatest point score improvement between any two of the three legs required to earn an Obedience title (i.e., CD, CDX, UD equivalent from AKC, ASCA, UKC) and the club member achieving the greatest point score improvement between any two of the three legs required to earn a Rally Title (i.e., RN, RA, RE equivalent from AKC, ASCA, UKC). To qualify: By November 15th Club members submit the form on the next page indicating the dates, names of the shows, and the scores for each leg to the Purchasing Committee Chairperson, who determines which club members had the most improvement between scores. The third leg of the eligible scores must be earned during the period of November 15 of the previous year to November 14 of the current year. There is no limit on the number of times a club member may earn and receive these awards. The awards are presented annually by DTCDC.

HOW TO SUBMIT YOUR SCORES: Scores must be submitted via U.S. Mail or email to Lynda Holman **BY NOVEMBER 15, 2018**.
