PROPOSED AMENDMENTS TO BYLAWS

Following are proposed amendments to the Bylaws which the Board voted to accept at its October 6 Board Meeting. The proposed amendments were then submitted to the membership via email before the October 13 General Meeting, with instructions for membership to submit discussion and input by the November 10 General Meeting If there are no membership submissions, the proposed amendments will be voted on at the November 10 General Meeting. Please submit any input to the Board and Bylaws Committee.

For your convenience, the Amendments section of the Bylaws is shown below.

ARTICLE VIII – AMENDMENTS

Section 1. Amendment Proposal

Amendments to the Constitution and Bylaws may be proposed by the Board, the Bylaws Committee, or written proposal from any Club member addressed to any member of the Board or Chair of the Bylaws Committee.

Proposed amendments shall be considered by the Board at the next regular Board meeting following receipt of the proposed amendments. (Hypothetical Timeline: For instance, if proposed amendments received at the end of January, Board would consider amendments at the February Board meeting.)

Following approval by the Board, the proposed amendments will be sent to the Bylaws Committee to check for consistency and agreement with the Bylaws. (Hypothetical Timeline: If Board approves proposed amendments at February Board meeting, the Bylaws Committee should receive proposed amendments from Board immediately after February Board meeting.)

The amendments will then be returned to the Board by the next regular Board meeting with any suggested changes. (Hypothetical Timeline: Bylaws Committee would have approximately 3-1/2 weeks to review and get proposed amendments with any Bylaws Committee suggested changes returned by the March Board meeting.)

Proposed amendments shall then be submitted to the membership at the next regular meeting, with instructions for submitting discussion and input within one (1) month of that meeting. (Hypothetical Timeline: Member would receive proposed amendments at the April club meeting and must submit his/her discussion/input by the May club meeting.)

After receipt of membership input, the Board and Bylaws Committee will prepare the final form of the proposed amendments and distribute same to the members in accordance with Section 2 (Amendment Voting). (Hypothetical Timeline: Board/Bylaws Committee would finalize amendment(s) during May and send to members 10 days prior to the June meeting.)

The final form of any amendment shall be presented to the membership for vote, noting the recommendation by the Board. (Hypothetical Timeline: Final form of amendment(s) could be voted on at June meeting.) Final voting by the active membership shall take place within three (3) months of the date the final form of proposed amendments were referred to the membership by the Board. (Hypothetical Timeline: Final voting could take place as early as June meeting or much later -- all dependent upon when Board sends final form of amendment to membership with Board's recommendation.)

Section 2. Amendment Voting

The Constitution and Bylaws may be amended by a two-thirds (2/3) vote of the Active Members present and voting at any regular meeting of the Club, provided the proposed amendment(s) have been included in the notice of the meeting and mailed to each member at least ten (10) days prior to the date of the meeting.

Amendments to DTCDC Bylaws

Proposed by Bylaws Committee and Approved by Board for Membership Approval (changes highlighted in yellow)

ARTICLE III – DIRECTORS AND OFFICERS

Section 2. Officers

E. It is preferable that the Treasurer have a bookkeeping or accounting background with experience in reconciling bank accounts, making journal entries, presenting financial information, preparing and reviewing financial statements (through the accounting software) and working with the outside CPA on the various tax filings. The Treasurer shall collect and receive all moneys due or belonging to the Club. He or she shall deposit the same in a bank approved by the Board in the name of the Club. The Treasurer shall disburse moneys for the routine operating expenses of the Club and may disburse up to five hundred dollars (\$500.00) for miscellaneous Club expenses. Amounts over five hundred dollars (\$500.00) are to be approved by the members of the Club; except in cases of dire emergency, in which case a majority of the Board may authorize payment.

a. After each month end, a copy of the prior month's bank statements, bank reconciliations and financial statements shall be sent to another DTCDC member to review. The reviewer could be the prior Treasurer or if this person is not available, another member with accounting experience. This reviewer will be appointed by the Board.

b. The books shall at all times be open to inspection by the Board, and the Treasurer shall report at every regular meeting of the Club the condition of the Club's finances and items of receipt of payment not before reported.

c. At the Annual Meeting, the Treasurer shall render an account of all moneys received and expended during the previous fiscal year. As soon as practicable, following the Annual Meeting, there will be a review of the financial records of the Club by the President and two (2) qualified Club members appointed by the Board.

d. The President, Treasurer and the Corporate Directors will be bonded up to at least fifty thousand dollars (\$50,000.00).

ARTICLE V – MEETINGS AND VOTING

Section 1. Club Meetings

Meeting(s) of the Club shall be held monthly at the DTCDC Club building at such time as may be designated by the Board. Club meetings may also be held by means of a remote electronic communications system, including telephone conferencing, videoconferencing technology or the Internet. Notice of each such meeting shall be given not less than five (5) days prior to the date of the meeting. The quorum for meetings shall be 20 percent of Active Members. Any notice to members required by these Bylaws may be provided by email unless expressly stated otherwise.

Section 2. Special Meetings

Special Club meetings may be called by the President or by a majority vote of the members of the Board who are present and voting at any regular or special meeting of the Board, and shall be called by the Secretary upon receipt of a petition signed by twenty percent (20%) of the Active Members of the Club. Such special meetings shall be held at the DTCDC Club building. Special meetings may also be held by means of a remote electronic communications system, including telephone conferencing, videoconferencing technology or the Internet. The date and hour shall be designated by the person or persons calling such meetings. The notice of such meetings shall be given by the Secretary not less than five (5) and not more than fifteen (15) days prior to the date of the meeting. Said notices shall state the purpose of the meeting and no other Club business may be transacted.

Section 3. Board Meetings

Meetings of the Board shall be held at the DTCDC Club building or other location at such hour as may be designated by the Board. Board meetings may also be held by means of a remote electronic communications system, including telephone conferencing, videoconferencing technology or the Internet. Special meetings of the Board may be called by the President and shall be called by the Secretary upon receipt of a written request by at least three (3) members of the Board. Notice of such meetings shall be given by the Secretary at least five (5) days prior to the date of the meeting. An e-mail or telecopy notice shall be deemed to be in writing. If telephone notice is given, all Board members not out of town must be reached. The quorum for such a meeting shall be a majority of the Board.

Section 4. Voting

Each Active Member shall be entitled to one (1) vote at any meeting of the Club at which he or she is present. Proxy voting will not be permitted at Club meetings.

Voting by the membership, Board or Committees of the Club referenced in these Bylaws may be conducted by the use of electronic balloting.

Materials that Informed the Bylaws Committee Proposed Amendments to Article V, Sections 1, 2 and 3: TEXAS BUSINESS ORGANIZATIONS CODE

TITLE 2. CORPORATIONS CHAPTER 22. NONPROFIT CORPORATIONS SUBCHAPTER A. GENERAL PROVISIONS Sec. 22.002. MEETINGS BY REMOTE COMMUNICATIONS TECHNOLOGY. Subject to the provisions of this code and the certificate of formation and bylaws of a corporation, a meeting of the members of a corporation, the board of directors of a corporation, or any committee designated by the board of directors of a corporation may be held by means of a remote electronic communications system, including videoconferencing technology or the Internet, only if:

(1) each person entitled to participate in the meeting consents to the meeting being held by means of that system; and

(2) the system provides access to the meeting in a manner or using a method by which each person participating in the meeting can communicate concurrently with each other participant.



(d) If authorized by the certificate of formation or bylaws of the corporation, a member vote on any matter may be conducted by mail, by facsimile transmission, by electronic message, or by any combination of those methods.



I used the Puppy Culture program from the day the puppies were born, and the program is very educational and provides so many tips and wonderful methods of introducing puppies to new experiences. They learned manding (sit and watch me) soon after they started eating solid foods. I see a marked difference in El's attentiveness as compared to other puppies I have raised and have received similar feedback from the other puppy owners. This program definitely made a difference in puppy's confidence level, attention span, and bidability. I would recommend it to all breeders.



Infection Control Directives for DTCDC Show & Go

Since we cannot know who each person comes in contact with during everyday life, we ask you to comply with the following directives. Please remember many exhibitors/friends are part of the higher risk group. We need to work together to keep everyone safe. If you are ill, do not come.

Everyone will BE REQUIRED to sign a "Waiver" and have their temperature taken before they will be allowed to exhibit their dog.

Minimize Personal Contact:

- 1. Everyone is encouraged to have the <u>Waiver completed prior to arrival</u>. We prefer to limit the use of community pens.
- 2. When inside the building, you MUST wear a mask/face covering over your nose and mouth. Anyone not complying will be asked to leave the premises and will not receive a refund on their entries.
- 3. Exhibitors are NOT REQUIRED to wear gloves. You may wear gloves, if you so choose. Minimize touching surfaces as much as possible.
- 4. All volunteers will all wear masks while in the building.
- 5. NO chairs will be provided.
- 6. Social distancing and masks will be enforced inside the building. They are strongly encouraged outside the building as well.
- 7. We recommend LIMITING group gatherings while outside. At the least, use masks & appropriate social distancing protocols.
- 8. You may bring lawn chairs, mats, battery fans, etc. to use while waiting to exhibit.
- 9. Every exhibitor may exercise their dog(s) in the yard at the back of the building. Return promptly to your vehicle and remain there until you are instructed to enter the premises. Remember, LIMIT group gatherings in the back yard & parking lot, wear your mask, and practice appropriate social distancing.
- 10. <u>Crating</u>: Due to Covid-19, we have limited crating. Only volunteers will be allowed to crate indoors. Everyone else will have to crate from your car.
- 11. <u>Volunteers</u>: You DO NOT need to be a DTCDC member to volunteer. Volunteer for at least two hours and if you have a dog to run-through, you will receive 10 minutes of ring time and be able to crate in the building while volunteering. Volunteers are needed to help run dogs through, steward, assist in notifying exhibitors when they can enter the building & clean-up
- 12. <u>Entries</u>: PRE-ENTRY ONLY & STRICT ADHERANCE TO SCHEDULED TIMES. ENTRIES LIMITED TO 7 HOURS. (8 AM – 3 PM)
 - Only one run per dog per class (Utility/Grad Open; Open/Grad Nov will be considered one class at this time)
 - Dogs entered in Utility only will begin at 8 am. Expect to show early.
 - Dogs entered in Utility & Open will follow. Open runs in the same order as Utility runs.
 - Dogs entered in other classes will be next. Expect to show after lunch & early afternoon.
- 13. You should not have to arrive more than 15 minutes before your scheduled ring time.
- 14. Park, open up your vehicle and come up to the pop-up tent in front of the building to check in.
- 15. Your temperature will be taken to confirm it is in the normal range (97°F 99°F) before you will be allowed in the building.
- 16. Everyone has a specific time slot(s) and you will be notified when to be ready to come into the building for your run(s).
- 17. You should be ready to come into the building when the dog scheduled ahead of you has entered the ring.

- 18. You will have the time scheduled for the dog ahead of you to warm your dog up in the building. This will continue for each class.
- 19. You will have ample room to warm up when inside.
- 20. Leashes/Dumbbells/Articles/Utility gloves will be handled with gloves, put out with tongs, or placed on a sanitized surface.
- 21. It will be your responsibility to sanitize your equipment after you leave.
- 22. If you are participating in a group exercise, please maintain appropriate CDC recommended social distance of 6 feet from one another.
- 23. We cannot permit guests in the building. No exceptions.
- 24. When using the bathroom, enter and leave the building using the back door. WASH HANDS according to the CDC recommendations.
- 25. NO DRINKS/FOOD ON PREMISE. Dog treats are allowed. No spitting of food to your dog.
- 26. Bring your own dog bowl & water in order to minimize contact & traffic to and from the bathroom.

Need a new trick to teach your dog?

How about this one: Teach Your Dog to Yawn!

This trick uses the "capture" technique, requiring timing and patience! Another approach to the same trick is to shape the yawn: click and treat for an open mouth, like panting, and gradually obtain a wider and wider mouth, and finally a yawn! This suggestion is from <u>doggiebuddy.com</u>. Have fun!

Difficulty: Moderate

Prerequisite: None

Items Needed: Clicker, Treats

The clock says the time is eleven-thirty. It's dark out and you're tired, and the couple on the couch haven't stopped talking. They are your friends, or used to be—you're not so sure now. But the greyhound in the corner is your friend. "Come here, boy," you whisper under the jabbering of the couple. He lays down by your legs and you look at him. You stare into his eyes and say, "Are you tired?" He smacks his lips and yawns, his great teeth revealing themselves, then disappearing again. "Yes, I know you're tired," you say and pat his head, "I am too." Your friends get the message.

Step 1: Most dogs will yawn when they are anxious. You can use that to help you catch the yawn. Look for your dog to yawn when he wants to go outside or wants a ball or toy that you are holding. When he yawns, click

and treat. Because this trick has to be 'caught' with the clicker, it can be fairly difficult, and you have to time your clicks just right.

Step 2: When he starts to offer a yawn because he has been treated for it, go ahead and give the command you want to associate with his action. It could be yawn, tired, or sleepy, but in any case, be consistent with your command. Repeat three to four times per session.

Step 3: After several sessions of training your dog to yawn, give him the command and see if he will respond with a yawn.

OUR EXPERIENCE

Because we have to catch Caspian in the act of yawning, it can be frustrating when trying to get him to yawn multiple times in a training session. Caspian will lick his muzzle and yawn if he is anxious, so sometimes during our training session, we would turn around and not say anything for a few seconds. Caspian, not knowing what to do, would then get a little anxious. An assistant would either click or let the trainer know when to click if he yawned (you won't be able to see your dog if your back is turned). This trick was more frustrating for Caspian in general. He knew that he was being clicked and treated for something that had to do with his mouth, but didn't quite understand at first. If your dog gets frustrated during a training session, cut back on the amount of time for each session, but always try to end on a high note.

TEACHING TROUBLE

My dog doesn't understand that he's being clicked for yawning. How can I fix this problem? Since a yawn is a natural response that a dog might give for either being tired or anxious, he usually doesn't even notice when he's doing it. Making him aware that he is yawning is the key to this trick. It may take several training sessions, but eventually your dog will get it!

Tip: "This trick presents better if you use a cute command like "Are you sleepy?" or "It's bedtime."
