Minutes of the previous meeting were read and approved.



Grace Robinson moved that the club donate Kristie Tufte's fee for training in grateful appreciation for the refreshments furnished at club meetings. Motion was seconded and carried.

Jim Walsleben moved that the business meeting stand adjourned at 8:15, and at that time he introduced our guests, Wade and Mary Campbell. Mr. Campbell addressed the club on "Tracking." Mr. and Mrs. Campbell were kind enough to answer questions at the end of his talk. Meeting was concluded at 9:30 p.m.

February 4, 1975

The regular meeting of The Dog Training Club of Dallas County was held February 4, 1975, at the William H. Atwell Junior High School, 1303 Reynoldston, in the Auditorium. At 7:40 p.m. the following two films were shown—"Basic and Novice Dog Training" and "Open Dog Obedience" by Milo and Margaret Pearsall. A discussion of the points illustrated by the films was conducted by the club Training Director, Lucile Tufte, for the members and guests present.

At 8:30 p.m., the business meeting was called to order by the President, Lynda Walker. There were 16 members present.

Minutes of the previous meeting were read and approved. The Secretary reported that she had had no response from Judy Schwander in regard to her query about membership status. The Secretary also reported that she had added a "Hold Harmless" agreement to the three-month lease of the training area.

The Treasurer reported a December 31st balance of \$871.53, with receipts for January of \$80.00 and disbursements of \$400.00, for a January 31st balance of \$551.53.

The Training Director reported that the new beginners class had ten paid and four members training. A new training class is planned for mid-February with Grace Robinson as instructor. A new time for the novice and open class on Thursday nights was agreed on as follows - jumps and open work from 7 to 7:30, heeling from 7:30 to 8:30, and drill team from 8:30 until 9:15. It was announced that the Treasurer has written for copies of the new obedience regulations and will be available at cost for those who want them.

Publicity Chairman announced that the Oak Cliff Tribune had published an article on the name change of the club, and she asked that if any members had stories from other local newspapers they be given to the Historian. Any changes for the roster were requested, as a current one is being prepared for print.

Katie Mieser asked that the Brownings be given a vote of thanks for arranging and presenting the program for this meeting.

March 14, 1975

The regular meeting of The Dog Training Club of Dallas County was held March 14, 1975, at the home of Lucile Tufte. Mr. Falkner gave a brief history of A.K.C and details of the changes in the Obedience Regulations, with a period of questions and answers following.


The business meeting was called to order by the President, Lynda Walker, at 9:45. There were 16 members and 3 guests present.

Minutes of the previous meeting were read and approved. The Secretary reported that letters of thanks had been written to Mr. and Mrs. Wade Campbell and to Mr. Joe McKnight. A letter written to the A.K.C. Director of Obedience Training asking for clarification of certain new rules had been sent and the answering letter had been zeroxed and distributed to the membership. A TERRARIUM HAD BEEN SENT TO KATIE MEISER WHILE SHE WAS IN THE HOSPITAL.

Treasurer's report showed a balance on hand January 31, 1975, of \$551.53. February receipts were \$263.00 and disbursements were \$215.96, leaving a balance on hand February 28th of \$598.57. Ruth Robinson moved that the Treasurer make an itemized statement of the Southwest Trophy billing and the balance due the club from Rose Callahan with proper payment being sent to her. Motion was seconded and carried.

The regular meeting of The Dog Training Club of Dallas County was held April 1, 1975, at Lucile Tufte's home, with Lynda Walker, President, presiding. Meeting was called to order at 7:50 p.m. There were 17 members and 2 guests present, with Mrs. Denise Chaney accepted as a new member in the club.

Minutes of the previous meeting were read and approved. The secretary reported that a letter of appreciation was sent to Mr. James Falkner for his talk at the March meeting, and a thank-you note from Katie Meiser was read.

Treasurer's report showed a balance on hand February 28, 1975, of \$598.57. March receipts were \$212.52 and disbursements were \$18.15, leaving a balance on hand March 31, 1975, of \$792.94.

Fun Match Chairman, Katie Blute, requested permission to purchase ribbons for matches to be planned in the near future. Permission was granted.

Drill Team Chairman, Susan Maxwell, announced that her assistant, Carolyn Cranford, would take charge of the drill team practice when the chairman was unable to attend.

Lucile Tufte, Training Director, announced that from the graduated class, four trainers will go on into the Novice class. She thanked "Mrs. Dr. Robinson" for her work with the large beginners class in training at present and reminded the group that all classes will be held in Kiest Park, starting April 3, 1975. Dates for the four Beginners classes at the park during the summer months were set, and the Director suggested that an all-out drive for as many classes as could be held in the areas of De Soto, Duncanville, and Grand Prairie be our goal in order to purchase our own training site. The class to be taught with the Waxahatchie Y will start April 7, 1975, with Ruby Walsleben and Susan Maxwell apprenticing with Lucile Tufte instructing.

The Training Committee recommended a Kindergarden Puppy Training class or classes be held, with a ten week program worked up with a suggested fee of \$25.00. The Committee moved that the club develop and carry out a K.P.T. program. Motion was seconded and carried. The Secretary was instructed to order booklets for these classes from Purina and from A.K.C. A meeting was set for April 6, 1975, for the Training Committee and apprentice teachers to work up a ten week course. It was moved and seconded that the cost of the supper during this session be charged to the club. Motion carried. The Training Director thanked the teachers and apprentices for their work during the indoor winter classes. Congratulations were extended to Gloria Nelson for her Lord Nelson's Lady Shannon, C.D. and to Maurine Leffingwell for the first leg on Maggie.

New rosters of current membership in the club were distributed.

Minutes of the Regular Meeting
May 6, 1975

The regular meeting of The Dog Training Club of Dallas County was held May 6, 1975, at the home of Lucile Tufte, with Lynda Walker, President, presiding. Meeting was called to order at 7:50 p.m. There were 14 members present.

Minutes of the previous meeting were read and approved. The secretary read the applications for membership in the club from Ronald Petty, William Barry Rutherford, Marc Wendeborn, Dee Henderson, Charles Michael, and Lisa Leffingwell. Motion was made by B. A. Moon that all six applicants be accepted into membership. Motion was seconded and carried. The secretary reported that letters had been written to A.K.C. and to Ralston Purina Co. ordering booklets for the K.P.T. classes and that the A.K.C. booklets had already been received. Letters were being prepared to accompany the K.P.T. publicity release to be mailed to local veterinarians in order to acquaint them with the program.

The Treasurer's report showed a balance on hand March 31, 1975, of \$792.94. Receipts for April were \$467.83 with disbursements of \$306.87, leaving a balance on hand April 30, 1975, of \$953.90.

Lynda Walker, Publicity Chairman, reported that ads had been prepared and publicity releases sent to all area publications announcing the Kindergarden Puppy Training classes.

The Training Director, Lucile Tufte, announced the schedule of beginner classes starting May 27 and continuing throughout the summer months. She also reported that four trainers who graduated in the last beginner's class had enrolled in the novice class. Plans for the K.P.T. class were announced, the first class to be held on May 14, 1975, at 7 p.m. and to run for ten weeks. It was suggested that those who finish the K.P.T. course with its fee of \$25.00 could either be placed in an existing beginner's class if only a few graduate or if too large in number could be placed in an entirely new class, with combined fee of \$25.00 for beginners and novice--the usual fee being \$35.00 for the combined course. The Training Director asked that we begin to look for a training area for the winter months, in particular getting information on locations for rent with option to purchase.

Susan Maxwell informed the group that she had two tickets for "A Day with A.K.C." that she would not be able to use and offered them to anyone who finds they can attend.

The President presented plaques for Lord Nelson's Lady Shannon, C.D., Bluteberry Muffin, C.D., and Li'l Acres Bo Jo Jones, C.D., to Gloria Nelson, Katie Blute, and Ruby Walsleben.

Under new business, Carol Day called attention to the problem of oversize training collars in the beginner's class, and the club instructed the teachers to urge the handlers to obtain properly sized collars and to nag if necessary.

Program Chairman, Ruby Walsleben, asked for suggestions for future programs. Grace Robinson mentioned that in assembling material for the K.P.T. class, a great deal of information interesting to others beyond puppy age had come

up and she suggested that this information could be presented at the meetings when the program is not too long. Information from the magazine, "Off Lead," concerning the controversy on height of jumps in Obedience Trials was discussed. Grace suggested that anyone feeling strongly either pro or con should draft a letter to A.K.C. and present it to the club. If the membership votes that it is in favor, the letter could be sent from the club; otherwise, individuals could write their personal views on the subject, sending it as such.

There being no further business, the meeting adjourned at 9:20 p.m.

Minutes of the Regular Meeting
June 3, 1975

The regular meeting of The Dog Training Club of Dallas County was held June 3, 1975, at the home of Lucile Tufte. Lynda Walker, President, called the meeting to order at 7:50 p.m. There were 18 members and 1 guest present.

Minutes of the previous meeting were read and approved. The Secretary reported that letters to all six newly accepted members had been written. She reported that no word had been received from the Ralston Purina Co. regarding the booklets ordered for the KPT classes and that she would follow up on this matter. No letters from the membership had been submitted about the feelings on height of jumps in open trials, so no action was taken.

The Treasurer's report showed a balance on hand April 30, 1975, of \$953.00. Receipts for May totalled \$827.60, with disbursements of \$89.52, leaving a balance on hand May 31, 1975, of \$1,691.98.

Lynda Walker, Publicity Chairmand, announced that she had obtained a quorum vote to authorize running ads in the area newspapers. One ad had been incorrectly run, but she was assured that the ad would be run correctly for extra weeks. Notice was called to the publications of the news releases concerning the KPT classes.

Fun Match Chairman, Katie Blute, moved that a fun match be held this month, and it was amended by Lucile Tufte that the match be held June 15th at 2 p.m. at Kiest Park. Motion as amended was seconded and carried. Lisa Leffingwell was named as a new member of the Fun Match Committee.

Training Director, Lucile Tufte, gave information about several fun matches scheduled in the near future. She reported that with the beginners classes, puppy classes, and advanced classes, the club has 96 people with more than 100 dogs in training--to quote--"pretty good for an area who doesn't train dogs." She suggested that the Thursday evening classes be extended to 1½ hour sessions to accomodate all the novice and open dogs. The next beginner class will start June 30th and area classes are planned with teachers being Maurine Leffingwell, Carolyn Cranford, and Ruby Walsleben. The next puppy class will start June 25th, and Lucile asked that members of breed clubs let their people know how well planned our KPT classes are. The training committee restated the rule that no one is to take a beginner dog unless specifically asked to by the instructor.

The Club letters arrived and are available at \$2.50 each. Also a booklet with jackets suitable for an emblem was passed among the members and suggestions for such an emblem were requested.

The Training Director reminded the membership that we should be working toward finding a training location for the colder months. Restrictions and zoning limits must be looked into, but if a place could be found, it could be used to the fullest extent to benefit the club.

Lucile also announced that she has decided to go for judging qualification and would welcome invitations to judge fun matches for any club interested.


The suggestion was made by Lynda Walker that when new registration forms for training classes are prepared, a question as to where the trainer heard about the club be added. This would show how effective our newspaper ads are.

The plaque for Bluteberry Muffin, C.D., was presented to Katie Elute who was absent at the May meeting.

Additions to the rosters were distributed. Grace Robinson announced the June 14th Seminar on Professional Dog Breeding. She also asked the club's permission to use copies of the Attack Training hand-outs of the club at her office, which was granted. Barry Rutherford suggested that the KPT material be copyrighted, but it was agreed that this should be postponed until some parts are revised.

B. A. Moon invited the club to hold the August meeting as a picnic at her home.

There being no further business, the meeting adjourned at 9:25 p.m.

July 1, 1975

The regular meeting of The Dog Training Club of Dallas County was held July 1, 1975, at the home of Lucile Tufte. The meeting was called to order by the President, Lynda Walker, at 7:50 p.m. There were 18 members present.

Minutes of the previous meeting were read and approved. The Secretary reported that she had called Ralston Purina Co. concerning the order of booklets and followed up with a letter. 

Grace Robinson named Lynda Walker, Lucille Tufte, and Maureen Leffingwell to the training committee.


