Linda gave the SWOA report. Our club is responsible for headquarters hospitality for the Gaines Classic to be held November 21 & 22. We will need volunteers to help on Friday before the weekend. We need to set up the welcome table. We are also responsible for the hospitality suite and we will need ideas for decorating doors. Needs to be a Texas theme.

Janice reported that the newspaper ads were running smoothly.

Robin reported that the demonstration for the FFA went very well. Helen did a demonstration for the Blue Birds.

Mary Jean announced that there will be informal scent hurdles practice held on Tuesday night before the classes start at 7:30.

Steve announced that the PA system is working. It is a portable system. He also mentioned that work needs to be done on the water heater and the insulation needs to be put down. The only problem with the water heater is that there is no gas line to heater and if a line is laid it will need to be approved.

Marty reported that for publicity she is establishing contacts with newspapers and she would like at least a weeks advance notice on any demonstrations in order to get them in the paper.

Linda stated that all housekeeping will be done on the third Thursday night of the month.

Linda brought up the fact that the Park Board is trying to prohibit dog training in public parks. The Park Board is having a meeting Tuesday, Feb. 10, at 3:00 p.m. at Dallas City Hall to discuss this matter. Linda called and talked to Mr. Johnson and he confirmed that there is an ordinance on dog training in the parks. No protection dog training is allowed, cannot train in public parks for profit, and have to prove non-profit status for permission. Grace will be the club's representative at this meeting.

There being no further business the meeting was adjourned at 9:05 p.m.

Dear Ms. Stout:

I am writing to make the following proposal to your Club,  
the Dog Training Club of Dallas County.

That the "serious" students from your classes and the "serious" from my classes join together for an all-day work session (perhaps 9 A.M. to 4 P.M.). The level of the handler/dog team would not be limited and could be polish Novice, Open or Utility. (We have in our midst an AKC tracking judge if you felt time would allow for expansion to include something on tracking)

What I have in mind would be a sharing of ideas, procedures, techniques and lots of on-the-floor sessions with dogs--just like an all-day training session. We could utilize team teaching, or break up into small sub-groups or just whatever would work best. I feel it would be to everyone's advantage to concentrate on basics: polish novice with emphasis on heeling, attitude of dog AND handler/trainer and motivation.

Saturday would be my preference for the day. Since you have the building we would come to you. Lunch could be picnic stuff with each person bringing what they want, or food could be brought in from a fast-food place near you. Perhaps it would be advisable to take a break from training and go to a nearby restaurant. These kinds of details could easily be worked out later.

My students are primarily Novice and Open and I would hope ten or so could participate.

I firmly believe such a workshop--without formal lectures--could be a unique experience for all. The opportunity for new ideas without embarrassment or put-down is rare. We certainly would have the advantage of learning in a low stress situation.



Lynda then presented the information her lawyers had worked up regarding incorporation. We cannot become non-profit with the federal government. We make a large percentage of our income from outside sources, it is not generated from membership but from general public. To file non-profit with the state of Texas we can go ahead and become a corporation. If we file for profit with Texas, and if we become a corporation we have to issue shares. But before we can do either the lawyers have to be sure we fall within non-profit for state of Texas. We can file non-profit and become a corporation and file for profit with the federal government, because of the property the lawyers suggested that we file for profit with the federal government.

The board suggested that Lynda ask the lawyers to see if we can be considered as non-profit for the state of Texas and become a corporation for profit. The board okayed Lynda to go ahead and get lawyers to check. She mentioned that after all this was done there would probably legal fees involved. It was also suggested that she put together all the pros and cons and that these be printed in the Paw Print for the general membership to consider before the January meeting.

It was also suggested that when and if we incorporate we get an auditor to go over the books.

Roberta mentioned that we still have some patches for awards of appreciation and it was suggested that the following people be presented with them: Tony Berger, Marty Martin, Robin & Steve German, Darlene Schermerhorn, Mylinda Bryant, Sharon LaCrois, Cindy Springer, Jackie Hunt, Valerie Fare, and Christy Hinterman.
