SECRETARY'S REPORT: Minutes of the previous meeting were corrected to indicate that the AKC world of purebred dogs book was offered only to board members since the special price offer expired prior to the regular meeting.

OLD BUSINESS:

PURCHASING: Toni Berger has not had time to do anything on getting prices for jackets, and Lynda has obtained brochures and price lists. She will get an estimate of those interested in purchasing new jackets before placing an order. Pam will contact Helen Cariotis to see if we can get our silk screen and embroidery disk back so that we will not have to pay a set up fee with the new supplier. Lynda is also purchasing new CD and CDX patches, and it was decided to go ahead and purchase a UD patch also. Lynda is also placing an order with J&J for new collars.

TRAINING: Barbara is going to check with Grace to find out the proper size for the snare. At the same time she will ask her to write a letter to the other vets promoting the club.

CALL TO ORDER: The meeting was called to order by the president, Pam Lee, at 7:45p.m.

SECRETARY'S REPORT: Copies of the minutes of the previous Board meeting and the March 5 regular meeting were distributed to those present.

OLD BUSINESS:

BUILDING RENTAL: The Chihuahua Club has rented the building on March 22, and the Bulldog Club has inquired about renting it on April 28 from 8:00 to 4:00. Pam will tell Valerie Fare to inform the Bulldog Club that the fee will be \$50 which must be submitted prior to the rental date to be used as the clean-up deposit. It will be kept as the rental fee if the building is left clean. If it is not clean, there will be an additional \$50.

JACKETS: The order for the jackets has been placed. Members will have to submit checks to the Club and the Club will issue one check to the vendor. Roberta gave Lynda the check, and Pam will pick up the jackets when they are ready. The minimum order for caps is 36 and there were not enough pre-orders from club members to place an order. It was decided that it would be too expensive for the Club to order 36 and then sell them.

TROPHIES FOR TKC: Members will have to be reminded to give Ruth Robinson a check if they donated a trophy to TKC.

ADVERTISING: Pam will ask Ruth if she has checked with the Dallas Morning News to find out if we are being charged for two ads. There were also two ads in the Lancaster paper and none in the DeSoto paper.

TELEPHONE: Roberta reported on her discussions with Southwestern Bell regarding the cost of changing the pay phone to a regular business line with call forwarding. The monthly cost would be considerably more than what we are paying now in addition to the enormous cost of installation. The telephone number would also have to be changed. There was discussion that a business line could possibly pay for itself, and we may get the persons who do not want to call several numbers in order to reach someone, and we could do the wiring ourselves. A motion was made, seconded and carried that we go ahead and change over to a business line if the cost will be under \$75. If it is over \$75 we will bring it up at the next regular meeting for approval. When we get the new number, we will have to change the newspaper ads. Roberta will also have to give a firm answer to the Yellow Pages about continuing our entry. The deadline is May 13, but they would like our answer right away.

TROPHIES: We need to order dumbbell trophies, nameplates and first place ribbons. It was decided to order 20 trophies, 25 nameplates and 20 statues. Ann Stone has already been informed to order the ribbons. It was also decided to order 20 "most-improved" ribbons without dates so that we will have them on hand.

VIDEO TAPE: Sandra Moody has made a Beta and a VHS tape for the library which will be available to club members. Ruth Robinson will be responsible for sending a tape to other clubs upon request. We will ask for a \$10 deposit to be refunded when the tape is returned. Evelyn Patterson will prepare some advertising. Sandra will make copies of the tapes for anyone who wants one at a cost of \$10 plus the blank tape.

#### NEW BUSINESS:

TATOO CLINIC: A tatoo clinic is being planned for Thursday night of the third week in April. Grace Robinson has offered to do the tatooing for \$10 for the first dog and \$7 for each additional dog in the same family. She has requested a lot of assistants.

MEMBERS IN ARREARS: There is a family who has not paid the annual dues and who owes some money that was left over from money advanced to buy some equipment for the building. Several attempts have been made to collect the money that was not spent on equipment. It was recommended that the secretary write them a letter outlining the conditions set forth in Article II. Sections 4 and 5, regarding members who are not in good standing with the club.

CABLE BROADCASTING: Judy reported that she had not been able to get in touch with Mary Warner regarding the use of the community access cable for a program on club activities. It was pointed out that if it has to be live, we may not be able to do it, but if we can put it on tape, we would be able to.

DEMONSTRATION: Judy said the demonstration scheduled for Sunday, March 31, is set.

SECRETARY'S REPORT: There was no report from the secretary.

TREASURER'S REPORT: The secretary reported the billing contract for the Yellow Pages ad amounts to \$11.25 per month, but we have not been billed that amount. 5. If a dog on which a training fee has been paid, changes owners before it completes a class, the original owner may transfer the right to complete that course to the new owner. Naturally, if this occurs, the original owner would not be entitled to any fee reduction on any new dog they subsequently wished to train.
6. Two or more dogs in the same household, training on the same class night, the fee for the second dog will be \$35.00. This will also apply to concurrent or consecutive classes.
